A local law to amend Village Ordinance No. 132, the Ordinance Fixing Water Rents

FIRST, that the Village Water Rents Ordinance No. 132 be amended by the substitution of a new water rate and a new grouping of consumers by amount of water used and which Section 1 will read as follows:

SECTION 1. Water rents to consumers within the corporate limits of the Village of Watkins Glen shall be based on the amount of water used each quarter, shall be billed on a quarterly basis and shall be as follows:

0-1000 C.F. Minimum charge	\$12.50
All over 1000 C.F. Per 100 C.F.	.35

SECOND, that this local law shall take effect on May 1, 1976.
