FIRST: Section 8C. LATE PENALTIES, subdivision (a) is hereby revoked and a new subdivision (a) is hereby adopted and shall read as follows:

Section 8C. LATE PENALTIES

(a) There will be a late payment penalty for all sewer user rates and sewer rents which are not paid by the date as shown on the billing statement.

SECOND: The changes herein provided for will become effective as of the 19th day of April 1982.

THIRD: This Local Law shall take effect the 19th day of April, 1982.
