A local law to amend Local Law Number 1 of the 1977 (Traffic Regulation)

The Traffic Regulation, Local Law No. 1 of 1977 of the Village of Watkins Glen, is hereby amended by the addition of an exception to subdivision 1, for trucks making local deliveries, and by the addition of subdivision 2 of Article XIII, Section 131, "Truck Exclusions," so that the said Section 131 reads as follows:

Section 131. Trucks over five (5) tons excluded. Trucks in excess of 5 tons are hereby excluded from the following highways within this Village:

1. On Decatur Street between its intersection with Fairground Lane and Fourth Street, except trucks making local deliveries.
2. On that portion of Reading Road between North Madison Avenue and/or Salt Point Road and State Route 14.

This Local Law shall take effect immediately upon filing with the Secretary of State.
