Numbering of Buildings Required:

Every owner or occupant of every building in the Village of Watkins Glen shall have placed thereon, in a place visible from the street or road, or highway, figures at least three and one-half (3-1/2) inches in height, of the number assigned to the property by the Schuyler County Fire Coordinator's Office and of a color contrasting with the color of the building such that the numbers are clearly legible from the adjacent street, road, or highway, showing the number of said building.

Effective Dates:

This local law will take effect 6 months after filing with the Secretary of State for existing buildings, and upon filing with the Secretary of State for all new construction.

Administration and Enforcement:

The Code Enforcement officer or agency is hereby designated to administer and enforce this local law.

Penalties for Offenses:

Any person who shall fail to install the assigned street address identification required pursuant to this Local Law, upon written order of the Code Enforcement Officer or Agency, shall be punishable by a fine not exceeding twenty-five dollars (\$25.00).
