A local law to amend Local Law No. 1 of 1977 (Traffic Regulation)

First. The Traffic Regulation, Local Law No. 1 of 1977, of the Village of Watkins Glen, is hereby amended by the addition of the following subsection to Article X, Section 102(a) prohibiting parking:

23. On the south side of Fifteenth Street, between a point 70 feet east of the east curb line of South Franklin Street and a point 334 feet east of the east curb line of South Franklin Street.

Second. The Traffic Regulation, Local Law No. 1 of 1977, of the Village of Watkins Glen, Article X, Section 103(a)(1) is hereby amended to read as follows:

1. On the north side of Fifteenth Street from the east curb line of Franklin Street to a point 70 feet easterly therefrom.

This Local Law shall take effect immediately upon filing with the Office of the Secretary of State.




