Section 103(a)(30) of Local Law No. 1 of 1977 (Traffic Regulation), which prohibits the standing of any vehicles on the south side of Second Street from the west curb line of Franklin Street to a point 44 feet westerly therefrom, is hereby amended to prohibit the standing of any vehicles on the south side of Second Street from the west curb line of Franklin Street to a point 33 feet westerly therefrom and from a point 79 feet westerly from the west curb line of Franklin Street to the east curb line of Madison Avenue.

Section 104(d) of Local Law No. 1 of 1977 (Traffic Regulation), which prohibits the stopping of any vehicles except taxi cabs on the north side of Sixth Street from a point 25 feet west of the west curb line to a point 65 feet west of the west curb line of Franklin Street, is hereby repealed.

Article X of Local Law No. 1 of 1977 (Traffic Regulation), which regulates Parking; Standing and Stopping of vehicles within the Village of Watkins Glen is hereby amended by the addition of the following section:

Section 107. The following locations shall be designated for angle parking only:

- (a) On the south side of Second Street from a point 33 feet westerly from the west curb line of Franklin Street to a point 79 feet westerly from the west curb line of Franklin Street.
- (b) On the north side of Sixth Street from a point 25 feet westerly from the west curb line of Franklin Street to a point 112 feet westerly from the west curb line of Franklin Street. Such angle parking in this designated location shall be limited to "compact cars" only. ("Compact cars" are hereby defined as motor vehicles less than 15 feet in length).

Local Law No. 3 of 1992 is hereby repealed and replaced by this Local Law, the purpose of this Local Law being to define a "no standing" area westerly of the angle parking area on Section Street.

This Local Law shall take effect immediately upon mailing to the Secretary of State.
