A local law to Amend Local Law No. 1 of 1977 (Traffic Regulation)

I. The Traffic Regulation, Local Law No. 1 of 1977 of the Village of Watkins Glen, as amended by Local Law No. 5 of 1983, and as further amended by Local Law No. 6 of 1989, is hereby further amended as follows:

Section 103(a) Standing prohibited in designated locations, is amended by the addition of Subdivision 75 and Section 102 (a) parking of vehicles is hereby prohibited in designated areas is amended by the addition of Subdivision 27, to read as follows:

102(a) 27 & 103(a) 75. On the south side of Ninth Street to a point forty (40) feet westerly from the westerly edge of the easterly driveway (exit) and to a point forty (40) feet easterly from the easterly edge of the easterly (exit) driveway.

II. The Traffic Regulation, Local Law No. 1 of 1977 of the Village of Watkins Glen, as amended by Local Law No. 2 of the year 1993, is further amended as follows:

A. Section 107(b) of Local Law No. 2 of 1993, which permitted angle parking on the north side of West Sixth Street from a point 25 feet westerly from the west curb line of Franklin Street to a point 112 feet westerly from the west curb line of Franklin St., is hereby repealed.

B. Parallel parking is reinstated in the area described in sub-section A above, for a maximum period of 2 hours.

III. The Traffic Regulation, Local Law No. 1 of 1977 of the Village of Watkins Glen, is further amended as follows:

A. Article X, Section 105 (Parking Time Limited in Designated Locations), Subsection (b), the parking of vehicles is hereby prohibited in any of the following locations for a period longer than two (2) hours unless otherwise prohibited or restricted by this local law in Art. X Sec. 100-101-102, 103-104 or 105(a), shall include: 12. On both sides of First Street between Franklin Street and the alley between Franklin and Decatur St.

IV. This Local Law shall take effect immediately upon filing with the Secretary of State.




