A LOCAL LAW PROVIDING FOUR YEAR TERMS FOR THE ELECTIVE OFFICES OF THE MAYOR AND TRUSTEES OF THE VILLAGE OF WATKINS GLEN.
Be it enacted by the of the
Village ofas follows:
SECTION 1.
Commencing at the beginning of the official year following the next General Village Election at which any of the offices of Mayor and Trustees are to be filled, and each Village Election thereafter, the terms of the office of the Mayor and the Trustees shall be four (4) years, instead of two (2) years.
This Local Law, by virtue of its enactment pursuant to Section 3-302, subdivision 5 (a) of the Village Law of the State of New York, shall extend the terms of Office of the elective Mayor and the elective Trustees.
SECTION 2.
If any one, or more, of the provisions of this Local Law shall be held invalid or unenforceable, all other provisions shall, nevertheless, continue in full force and effect.
SECTION 3.

Pursuant to Section 9-900, subdivision 2 of the Village Law of the State of New York, the Village Clerk is hereby authorized and directed to post and publish a notice within ten (10) days of the adoption of this Local Law, which notice shall set forth the date of the adoption of this Local Law and contain an abstract of this Local Law concisely stating the purpose and effect thereof, and indicating that such Local Law is subject to a Permissive Referendum.

## SECTION 4.

Following the passage as the result of such Permissive Referendum as may be called for by the resident electors of the Village, or in the absence of such Permissive Referendum, upon the expiration of the time period within which a Permissive Referendum may be called for, this Local Law shall thereafter take effect immediately upon its filing in the Office of the Secretary of State of the State of New York as provided in Section 27 of the Municipal Home Rule Law.
