Separate bids for the construction of the Watkins-Montour Regional Wastewater Treatment Plant Contract No. 2, addressed to the Village Clerk, Village of Watkins Glen, will be received by the Village of Watkins Glen for the construction of the Watkins-Montour Regional Wastewater Treatment Facility (WMRWWTF). Bids will be received by the Watkins Glen Village Clerk, 303 North Franklin Street, Watkins Glen, New York 14891, until **1:00 p.m. local time on Tuesday, April 25, 2017** at which time the Bids received will be publicly opened and read. Bids received after the specified time will not be considered.

The Project consists of constructing a new municipal wastewater treatment plant, including administration building, headworks, sequencing batch reactor system, tertiary filter, UV disinfection, and appurtenances as detailed in the contract documents.

Bids are invited for the following separate schedules of the work:

- B. 2B: Electrical Construction
- C. 2C: HVAC Construction
- D. 2D: Plumbing Construction
