The Village Sewer Ordinance #152 is hereby amended as follows:

FIRST. Section 8-A. Sewer User Rates is hereby amended by changing the amount of the sewer user rates and the billing period in subdivision (b) and by the elimination of subdivision (e) of said section.

Section 8-A. SEWER USER RATES, subdivision (b) shall read as follows:

(b) Sewer user charges shall be assessed against each unit based on the cubic feet of water consumed by said unit on a monthly basis which charge shall be billed on a monthly basis. The charge shall be as follows:

0-300 c.f. minimum charge per month	\$4.74
over 300 c.f. per month	1.58 per ccf.

Section 8-A. SEWER USER RATES, subparagraph (e) is hereby repealed.

Section 8-A. SEWER USER RATES, subparagraph (f) is hereby renumbered Section 8-A (e).

SECOND. Section 8-B. SEWER RENTS is hereby amended by changing the sewer rental charges from an annual to a monthly charge and increasing them from \$42.00 per year to \$4.00 per month.

Section 8-B. SEWER RENTS, subparagraph (b) of said Section 8-B is hereby repealed and a new Section 8-B (b) is hereby adopted and shall read as follows:

- (b) The monthly sewer rental charge for each unit which is located within the geographical boundaries of the Village of Watkins Glen is hereby established as \$4.00 per month; monthly sewer rental charges for each unit which is located outside of the geographical boundaries of the Village will be as agreed upon between the Village and the owner of the unit or the Sewer District within which the unit is located. The charges herein provided for shall be payable as part of the monthly billing of the user.

THIRD. There is hereby added to Village Ordinance #152 a new section entitled Section 8-C. LATE PENALTIES and shall read as follows:

Section 8-C.

- (a) There will be a late payment penalty for all sewer user rates and sewer rents which are not paid by the user within 30 calender days of the mailing of the bill to the user.
- (b) The amount of the penalty will be a one-time 10% computed on the delinquent sewer user rates and sewer rents.
- (c) All sewer user rates and sewer rental penalties charged pursuant hereto shall constitute a lien upon the real property upon which they are imposed, in accordance with Article 14-F of the General Municipal Law of the State of New York.

FOURTH. The changes herein provided for will become effective as of the 20th day of October, 1981.

FIFTH. This Local Law shall take effect the 20th day of October, 1981.

5. (City local law concerning Charter revision proposed by petition.)


