The Village Ordinance #132, the Ordinance Fixing Water Rents is hereby amended by the change of Section 1 thereof in the amounts to be charged for water and in the grouping of consumers by the amount of water used and by a change in the billing period from quarterly to monthly and by the addition of a penalty for late payemnts.

First. The Village Water Rents Ordinance #132 is hereby amended to read as follows:

"Section 1. Water rents to consumers within the corporate limits of the Village of Watkins Glen shall be based on the amount of water used each month shall be billed on a monthly basis and shall be as follows:

0-300 c.f. minimum charge per month \$5.00 over 300 c.f. per month 1.30 c.c.f.

Second. There is hereby added to Village Ordinance #132 a new section entitled Section 4. LATE PENALTIES, and shall read as follows:

## " Section 4. LATE PENALTIES

Be it enacted by the Board of Trustees

- (a) There will be a late payment penalty for all water rents which are not paid by the user within 30 calender days of the mailing of the bill to the user.
- (b) The amount of the penalty will be a one-time 10% computed on the delinquent water rents.
- (c) All water rent penalties charged pursuant hereto shall constitute a lien upon the real property upon which they are imposed, in accordance with Article 14-F of the General Municipal Law of the State of New York."
