A local law to amend Local Law Number 1 of 1977 (Traffic Regulation)

The Traffic Regulation, Local Law No. 1 of 1977 of the Village of Watkins Glen, is hereby amended by the addition of the following subdivisions to Article X, Section 105, Parking Time limited in designated locations:

(c) The parking of vehicles is hereby prohibited in any of the following locations for a period longer than fifteen (15) minutes:

- 1. On both sides of Franklin Street between Eighth Street and Ninth Street

(d) The parking of vehicles is hereby prohibited in any of the following locations for a period longer than thirty (30) minutes:

- 1. On the west side of Franklin Street between Sixth Street and the first alleyway northerly therefrom.

This Local Law shall take effect immediately upon filing with the Secretary of State.
