The Traffic Regulation, Local Law No. 1 of 1977 of the Village of Watkins Glen, is hereby amended by the addition of the following subsection to Article X, Section 105 (b) (Parking time limited to 2 hours):

8. On the south side of Third Street, between Franklin Street and Decatur Street.

This Local Law shall take effect immediately upon filing with the Secretary of State.
