The Traffic Regulation, Local Law No. 1 of 1977 of the Village of Watkins Glen, as amended by Local Law No. 5 of 1983, is hereby amended by the addition of the following subdivision to Article X, Section 105 (c), The parking of vehicles prohibited for a period longer than fifteen (15) minutes:

2. On the west side of Franklin Street between a point 107 feet northerly from the north curb line of Fourth Street to a point 150 feet northerly from the north curb line of Fourth Street.

This Local Law shall take effect immediately upon filing with the Secretary of State.




