The term "special events" shall include only those local public events which are specifically designated as such by the Watkins Glen Village Board of Trustees for purposes of permitting the employment of civilians for crowd control and traffic control pursuant to this Local Law.

The specific persons so employed shall be on each and every occasion approved in advance by the Watkins Glen Village Board of Trustees, and their employment for such purposes shall be at all times under the direct supervision of the Village of Watkins Glen Police Department.
