Local Law No. 5, 1981, the Local Law Fixing Water Rents is hereby amended by the change of Section 1 thereof in the amounts to be charged for water.

FIRST. The Village Water Rents Local Law no. 5, 1981 is hereby amended to read as follows:

"Section 1. Water rents to consumers within the corporate limits of the Village of Watkins Glen shall be based on the amount of water used each month, and shall be as follows:

0-300 c. f. minimum charge per month	\$ 5.50
Over 300 c. f. per month	1.43 c. c. f.
Water Rent Charge	2.00"

Local Law No. 4, 1981, the Local Law Fixing Sewer User Rates is hereby amended by the change of Section 8-A there of in the amounts to be charged for sewer usage.

FIRST. SEWER USER RATES, subdivision (b) shall read as follows:

(b) Sewer user charges shall be assessed against each unit based on the cubic feet of water consumed by said unit on a monthly basis which charge shall be billed on a monthly basis. The charge shall be as follows:

0-300 c. f. minimum charge per month	\$ 5.45
Over 300 c. f. per month	1.82 per ccf.

SECOND. Section 8-B. SEWER RENT charges will be \$4.00 per month.

THIS LOCAL LAW SHALL TAKE EFFECT THE 28th DAY OF AUGUST, 1987.
