A local law to amend Local Law Number 1 of 1977 (Traffic Regulation)

Be it enacted by the Board of Trustees of the

The Traffic Regulation, local law No. 1 of 1977 of the Village of Watkins Glen, is hereby amended in the following particulars:

FIRST. Article X, Section 102 (a) (12) prohibiting parking on the south side of Fourth Street between Magee Street and a point 80 feet east of the east curb line of Perry Street is hereby deleted.

SECOND. Article X, Section 103 (a) (49) is hereby amended to prohibit standing on the north side of Fourth Street between a point 80 feet westerly from the west curb line of Perry Street and a point 80 feet easterly from the east curb line of Perry Street.

THIRD. Article X, Section 103 (a) prohibiting standing, is hereby amended to add the following subsection

71. On the south side of Fourth Street between Magee Street and a point 50 feet west of the west curb line of Magee Street and between a point 80 feet westerly from the west curb line of Perry Street and a point 50 feet east of the east curb line of Perry Street.

FOURTH: Article X, Section 105 (6) prohibiting parking for a period longer than two (2) hours, is hereby amended to add the following subsections:

8. On the south side of Fourth Street between a point 50 feet west of the west curb line of Magee Street and 50 feet east of the east curb line of Perry Street.

9. In the Municipal Parking lot situated east of Franklin Street between Fourth and Fifth Streets.

10. In the Municipal Parking lot situated east of Franklin Street on the north side of Third Street.

This local law shall take effect immediately upon filing in the Office of The Secretary of State.
