- I. Local Law No. 1 of the Year 1977 (Traffic Regulation) is hereby amended in the following particulars:
 - A. Article X, Section 103 (Standing Prohibited in Designated Locations), Subsection 56, is hereby amended to read as follows:

On the West side of Franklin Street between a point 8 feet southerly from the prolongation of the south curb line of First Street to the south curb line of Division Street.
 - B. Article X, Section 103 (Standing Prohibited in Designated Locations), Subsection 57, is hereby amended to read as follows:

On the East side of Franklin Street between a point 50 feet southerly from the prolongation of the south curb line of Division Street to a point 120 feet northerly from the prolongation of the north curb line of Division Street.
- II. Local Law No. 5 of 1983 (Amendment to Local Law No. 1 of 1977) is hereby amended in the following particulars:
 - A. Article X, Section 105 (Parking Time Limited in Designated Locations), Subsection (d)(1) is hereby repealed, and a new subsection (d)(1) is substituted to read as follows:
 - (d) The parking of vehicles is hereby prohibited in any of the following locations for a period longer than thirty
