- 1.  $\underline{\text{TITLE}}$ . This local law shall be known as the Games of Chance Law of the Village of Watkins Glen.
- 2. <u>DEFINITIONS</u>. "<u>Authorized Organization</u>" shall mean an authorized organization as defined in §4 of §186 of the General Municipal Law. "<u>Games of Chance</u>" shall mean a game of chance as defined in §3 of §186 of the General Municipal Law.
- 3. GAMES OF CHANCE AUTHORIZED. Authorized organizations, may upon obtaining a license from the Village Clerk, conduct games of chance within the Village of Watkins Glen as provided in Article 9-A of the General Municipal Law and as provided further in this local law. Such games of chance shall be conducted in accordance with the laws of the State of New York and with the rules and regulations adopted by the New York State Racing and Wagering Board and pursuant to this local law.
- 4. RESTRICTIONS. The conduct of games of chance shall be subject to the restrictions imposed by \$189 of the General Municipal Law.
- 5. <u>SUNDAY GAMES</u>. Games of Chance may be conducted on Sunday pursuant to this local law. However, no games of chance shall be conducted on Easter Sunday, Christmas Day or New Year's Eve.
- 6. <u>ENFORCEMENT</u>. The Chief of Police of the Watkins Glen Police Department shall exercise control over and supervision of all games of chance conducted under duly authorized license. The Chief of Police shall have all those powers and duties set forth in and for the enforcement of Article 9-A of the General Municipal Law.
- 7. EFFECTIVE DATE. This local law shall take effect immediately upon filing with the office of the Secretary of State, following its approval by majority of the qualified voters of the Village of Watkins Glen voting on a proposition therefor, at general election held pursuant to the provisions of §24 of the Municipal Home Rule Law.
