The erection or maintenance of any sign or billboard within the Village of Watkins Glen, which is rented or used to advertise a product, service or establishment which is not the principal product, service or establishment found on the property containing the sign or billboard, is hereby prohibited. Such signs as may exist within the Village of Watkins Glen as of the date of enactment of this Local Law shall be exempt from the provisions of this Local Law.

The Village of Watkins Glen Board of Trustees, with the advice of the Village's Planning Board, may in its sound discretion, and in the best interests of the Village, grant exceptions to this Local Law upon written application of the property owner.

For any and every violation of the provisions of this Local Law, the owner of the property on which the sign or billboard is located and/or the owner of the sign or billboard, shall be held liable on conviction thereof for a fine or penalty of not less than fifty dollars (\$50.00), nor more than two hundred fifty dollars (\$250.00) for each and every offense. Each week of continued violation shall constitute a separate additional offense.

This Local Law shall take effect immediately upon filing with the Secretary of State.
