Local Law No. 3 of the year 1990

A local law to amend Ordinance No. 132, as amended, the Ordinance Fixing Water Rents

Be it enacted by the Board of Trustees of the

Village Ordinance No. 132, the Ordinance Fixing Water Rents, as amended by Local Law No. 5 of 1981 and Local Law No. 5 of 1987, is hereby amended by the addition of a new section numbered SECTION 7 creating a new class of water users to be known as Heavy Industrial/Commercial Users, to read as follows:

SECTION 7. (a) There is hereby created a class of water users to be known as Heavy Industrial/Commercial Users, defined as those users of Village water who require a 6-inch diameter or more (static or dynamic) supply line for any internal system or purpose.

(b) Heavy Industrial/Commercial Users shall be required to pay a water connection fee of \$25,000.00 at the time of hooking up the 6-inch or greater diameter supply. Thereafter, on the anniversary date of such hookup, such users shall be required to pay the sum of \$15,000.00 per year as water rents, for a period of 5 years, or until the total sum of \$100,000.00 shall have been paid pursuant to this Section (\$25,000.00 installation fee and \$75,000.00 of annual water rents).

(c) In addition said users shall pay any and all rents and water use charges for water actually used, as required by Local Law No. 5 of the year 1987:

This Local Law shall take effect immediately upon filing with the Secretary of State.
