1. The Traffic Regulation, Local Law No. 1 of 1977 of the Village of Watkins Glen, Article VIII, STOP AND YIELD INTERSECTIONS, is hereby amended by the deletion from Section 80 (stop intersections) of the intersection of Fairgrounds Lane and Decatur Street and by the following addition to Section 81 (yield intersections):

<u>Intersection of</u>	<u>With/Yield Sign On</u>	<u>Entrance(s)</u>
Fairgrounds Lane	Decatur Street	North

2. The Traffic Regulation, Local Law No. 1 of 1977, of the Village of Watkins Glen, Article VIII, STOP AND YIELD INTERSECTIONS, Section 80 (stop intersections) is hereby further amended by the addition of the following:

<u>Intersection of</u>	<u>With/Stop Sign On</u>	<u>Entrance(s)</u>
Bath Street	Glen Avenue	North and South
Bath Street	Summit Avenue	North
Summit Avenue	Upper Steuben Street	West
Franklin Street	Lincoln Way	East
9th Street	Decatur Street	North and South
12th Street	Decatur Street	North and South

3. This Local Law shall take effect immediately upon filing with the Secretary of State.


