Be it enacted by the BOARD OF TRUSTEES of the Village of WATKINS GLEN as follows:

1. Local Law No. 7 of 1989 of the Village of Watkins Glen is hereby repealed.
2. The riding or use of skateboards within the Village of Watkins Glen is hereby prohibited in the following locations:
  - a. On Franklin Street (State Rte. 14), Fourth Street (State Rte. 414), Decatur Street and on any Village Parking Lot.
  - b. On the sidewalks along Franklin Street and along Fourth Street from one block east of Franklin Street to one block west of Franklin Street.
3. In all other areas of the Village of Watkins Glen, the riding or use of skateboards in a reckless manner is hereby prohibited. The term "reckless" shall have the same meaning as defined in the Penal Law of the State of New York, Section 15.05 (3).
4. Violation of this Local Law shall be deemed a Violation as defined in the Penal Law of the State of New York and shall be punishable as such, and in addition thereto shall be subject to immediate seizure and forfeiture of the instrumentality (skateboard) used by the alleged violator.
5. Following a hearing conducted by the Village Board of Trustees, upon written application of the owner of the seized property (skateboard), the Board may, in the interests of justice and for good cause shown, return the seized property (skateboard). In the event of final disposition of the charges in favor of the alleged violator, the said seized property (skateboard) shall likewise be returned to its owner.
6. This Local Law shall take effect immediately upon filing with the Secretary of State.
