23. On the south side of Fifteenth Street, between a point 70 feet east of the east curb line of South Franklin Street and a point 334 feet east of the east curb line of South Franklin Street.

<u>Second.</u> The Traffic Regulation, Local Law No. 1 of 1977, of the Village of Watkins Glen, Article X, Section 103(a)(1) is hereby amended to read as follows:

1. On the north side of Fifteenth Street from the east curb line of Franklin Street to a point 70 feet easterly therefrom.
