Local Law No. 5, 1981, as amended by Local Law No. 5, 1987, as amended by Local Law No. 4, 1988, is hereby amended for clarification by the change of Section 1 thereof in the amount to be charged for water and the addition of Section 2 the amounts to be charged for water rent.

FIRST. The Village Water Rents, Local Law No. 5, 1981 as amended by Local Law No. 5, 1987, as amended by Local Law No. 4, 1988, is hereby amended to read as follows:

Section 1. Water user charges to consumers within the corporate limits of the Village of Watkins Glen shall be based on the amount of water used each month, and shall be as follows:

0-300 c.f. minimum charge per month \$6.00 Over 300 c.f. per month \$2.02/c.c.f.

- Section 2. (a) The water rent established by Local Law No. 5 of 1987, shall be for each assessment unit having a water service available.
 - (b) The water rental charge for each assessment unit which is located within the geographical boundaries of the Village of Watkins Glen is and has been previously established as \$2.00 per month. The monthly water rental charge for each incidence of connection made to Village-supplied lines outside the geographical boundaries of the Village of Watkins Glen is hereby reiterated to be established as \$3.00 per month to reflect and reiterate the 1 and 1/2 rate regularly imposed on consumers outside the corporate limits of the Village.

- (c) These water rents shall be in addition to the water user charges established in Section 1 of this local law.
- (d) Said water rental charge shall be for the benefit of capital improvements to the public water of the Village of Watkins Glen, New York and each and every part thereof together with the necessary appurtenances thereto including, but not by way of limitation, a pumping station, water mains and a water treatment plant.
- (e) All water rental charges shall constitute a lien upon the real property upon which they are imposed, in accordance with Article 14-F of the General Municipal Law of the State of New York.

This local law shall take effect immediately upon filing with the Secretary of State.
