A local law to Amend Local Law No. 5 of 1981 and Local Law No. 4 of 1981

I. Local Law No. 5 of 1981, as amended by Local Law No. 5 of 1987 and by Local Law No. 4 of 1988, is hereby amended by the addition of a Section 2 to read as follows:

Section 2. Water rents shall be charged only to those properties at which there is water service available and connected to a structure on the property. In the event of a disconnection for a period in excess of 90 days, water rents shall cease to be charged for the subject property. Upon connection or reconnection, a fee shall be charged to the property owner in an amount as from time-to-time determined by resolution of the Board of Trustees.

II. Local Law No. 4 of 1981, as mended by Local Law No. 5 of 1987 and by Local Law No. 4 of 1988, is hereby amended by the addition of Subsection THIRD to Section 8-A, to read as follows:

THIRD. Sewer rents shall be charged only to those properties at which there is sewer service available and connected to a structure on the property. In the event of a disconnection for a period in excess of 90 days, sewer rents shall cease to be charged for the subject property. Upon connection or reconnection, a fee shall be charged to the

property owner in an amount as from time-to-time determined by resolution of the Board of Trustees.

III This Local Law shall take effect immediately upon mailing to the Secretary of State. This Local Law shall not be construed in any manner as to require payment of any refund of any water or sewer rents paid up to the date this Local Law becomes effective.
