- The owner, lessee, occupant or person in control of any lot in the Village of Watkins Glen shall keep such lot, including the area between the sidewalk and curb or street, free from all brush, briars, weeds, tall noxious grasses, rodents and vermin, debris, manure, rubbish, salvage materials or miscellaneous refuse of any kind. If any such owner, lessee, occupant or person in control of any such lot shall fail to remove any such weed, grasses, brush, briars, manure, rodents, vermin, rubbish, salvage materials or miscellaneous refuse as aforesaid within forty-eight (48) hours after notice by the Village to do so, the Village may itself effect such removal, either by its own crews or by contracting with others, and may assess to such owner, lessee, occupant or person in control of such property, the actual reasonable cost of such removal, with a minimum charge of fifty dollars Service of such notice to remove may be made personally or by (\$50.00).certified mail, or by leaving such notice with a person of suitable age and discretion in any building upon such lot, or in the case of a vacant lot, where the address of the owner, lessee, occupant or person in control thereof is not known, by affixing said notice to some object thereon where it is likely to be seen. Upon failure of such owner, lessee, occupancy or person in control of any such lot to pay the costs assessed for removal by the Village, within ten (10) days of billing, the Village may commence an action at law to recover the same.
- 2. Any person who fails to comply in a timely manner with the Notice to Remove, served in accordance with subdivision 1, and by reason thereof the Village undertakes to effect such removal, shall, in addition to the charges set forth above, be liable to prosecution of charges as provided in the Penal Law for Violations, and shall be subject to the fines and penalties prescribed by the Penal Law for Violations.
- 3. The Code Enforcement Officer of the Village of Watkins Glen shall have the responsibility and authority to enforce this local law.
- 4. Effective Date. This Local Law shall take effect immediately upon mailing to the Secretary of State.
