Permit System for Trucks over Five (5) Tons

Local Law No. 1 of the Year, 1977 and Local Law No. 6 of the Year, 1984, Subdivision 2 of Article XIII, Section 131, "Truck Exclusions", is hereby amended so that the said Section 131 reads as follows:

Section 131.

1. The operation or the parking of any trucks, commercial vehicles, tractors or tractor trailers which have a weight in excess of five (5) tons is hereby prohibited from all village streets, except those which are State or County Highways, for all purposes other than local delivery.

2. Where strict adherence to this prohibition would be wasteful, impracticable or against the public interest or safety, the Watkins Glen Village Board of Trustees, may grant a permit or permits which will allow trucks over five (5) tons to operate on Village streets. Such permit(s) shall be granted only upon application of the individuals(s) or corporation(s) owning or operating such trucks, and upon good cause shown. Reasonable restrictions may apply. Such permit(s) shall be granted for a one-year term, and shall be renewable annually upon re-application and reconsideration. The Watkins Glen Village Board of Trustees reserves the right to terminate such permit(s) immediately for good cause, or for any reason on 30 days notice.

3. This Local Law shall take effect immediately upon filing in the office of the Secretary of State.
