Local Law No. 1 of 1992 is hereby amended as follows:

Section 1. Water user charges charges to consumers within the corporate limits of the Village of Watkins Glen shall be based on the amount of water used each month, and shall be as follows:

0-300 c.f. minimum charge per month \$9.00
over 300 c.f. per month 3.60/c.c.f.

In addition, the rental rate shall be increased from \$2.00 per month to \$3.00 per month.

This local law shall take effect September 9, 1996.




