- 2. Local Law No. 3 of the Year 1991 (The Zoning Law of the Village of Watkins Glen) is hereby amended by the addition of Section 1.27 to ARTICLE IV, DEVELOPMENT GUIDELINES AND GENERAL PROVISIONS, to read as follows:

Section 1.27 - New construction or installation of one and two-family residential homes, including mobile homes, prefabricated modular homes or manufactured homes, shall conform to the following standards which shall be regarded as minimum standards:

- A. Minimum Lot Size, frontages, setbacks and off street parking requirements, etc. shall conform to the standards of the district wherein it is proposed to construct or install the new residential one or two-family home.
- B. Square footage of the main living area in the residential structure (excluding porches, decks, garages, whether attached or detached, shed, unheated storage space, basement, etc. shall be a minimum 1,200 square feet.
- C. The newly constructed or installed one or two-family home shall be built upon a permanent cinder block or concrete foundation, extending a minimum of four (4) feet below the ground level.
- D. Construction or installation shall be in all other respects in conformity with requirements and standards of the NYS Fire and Building Code.

This Local Law shall take effect immediately upon filing with the Office of the Secretary of State.
