The Traffic Regulation, Local Law No. 1 of 9777 of the Village of Watkins Glen, is hereby amended by the addition of the following subsection to Article X, SEction 102(a) prohibiting parking:

25. Anywhere in any of the alleys belonging to the Village of Watkins Glen, to wit, North Clute Park Drive, South Clute Park Drive, Tooker Drive, Saverne Place, Jefferson Way, and Aubles Alley.

This Local Law shall take effect immediately upon filing with the Office of the Secretary of State.


