2. On the north side of Tenth Street from a point sixty (60') feet east of the east curb line of Franklin Street to a point one hundred eighty (180') feet west of the driveway entrance to the parking lot behind the Schuyler County Jail and Courthouse complex.

ARTICLE X is further amended to prohibit the parking of recreational vehicles in excess of sixteen (16') feet in length on village streets for a period in excess of seventy-two (72) hours, and to further prohibit the overnight occupancy of any vehicle parked on a village street.
