A Local Law Annexing certain territory and incorporating same within the corporate boundaries of the Village of Watkins Glen, pursuant to the provisions of General Municipal Law Article 17.		
Be it enacted by the	Board of Trustees	of the
Village of	Watkins Glen	as follows:

#### **SECTION ONE**

#### LEGISLATIVE DECLARATION

- A. A petition in writing has been presented to the Board of Trustee of the Village of Watkins Glen, New York, signed by owners of real and personal property of the territory described in this Local Law requesting annexation of their properties to the Village of Watkins Glen.
- B. A public hearing before the Board of Trustees was held on May 23, 2005, pursuant to resolution of the Board, and notice of the public hearing was published in the Watkins Review and Express on April 20, 2005.
- C. It appears that annexation of such territory is in the overall public interest and would be a benefit to the Village as a whole.

#### **SECTION 2**

#### ANNEXATION OF TERRITORY

By this Local Law, there is annexed to the Village of Watkins Glen, County of Schuyler, State of New York, and incorporated within the corporate boundaries of the Village, the following territory adjoining the present corporate boundaries of the Village:

#### **SECTION 3**

#### **NEW VILLAGE LIMITS**

The corporate limits of the Village of Watkins Glen are extended and increased so as to include and embrace within the corporate limits of the Village of Watkins Glen, the territory described in Section 2, and such territory is declared to be part of the Village of Watkins Glen.

#### **SECTION 4**

#### EFFECTIVE DATE

This Local Law shall take effect on the first day of June, of the year two thousand and six.

#### GIBSON LANDS

That portion of the following described property situate outside the present boundaries of the Village of Watkins Glen:

ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Reading, County of Schuyler and State of New York, described as follows: Commencing at a point in the center of Steuben Street at the southeast corner of lands now or formerly of Mrs. William Peck; thence running north along the east line of land of said Peck about one hundred seventy (170) feet to lands now or formerly of D.C. Jansen; thence easterly along said Jansen's land sixty-six feet; thence southerly parallel with the first named line one hundred seventy (170) feet to the center of Steuben Street; and thence westerly along the center of Steuben Street to the place of beginning.

EXCEPTING FROM THE ABOVE, ALL THAT PIECE OR PARCEL OF PROPERTY, hereinafter described situate in the Town of Reading, County of Schuyler and State of New York described as follows:
