Local Law No. 2 of the Year 2015

A Local Law to amend Local Law No. 2 of 2009 – Water Usage Rates

Be it enacted by the BOARD OF TRUSTEES of the

Village of WATKINS GLEN as follows:

Local Law No. 2 of 2009 is hereby amended as follows:

Section 1. Water user charges to consumers within the corporate limits of the Village of Watkins Glen shall be based on the amount of water used each month, and shall be as follows:

0-300 c.f minimum charge per month	\$12.00
or 0-2,250 gallons minimum charge per month	\$12.00
Additional per 100 c.f. over 300 c.f.	\$ 3.95
Additional per 1,000 gallons over 2,250	\$ 5.28

In addition, the water rent charge shall be increased from \$5.00 per month to **\$6.00** per month for such users.

Section 2. Water user charges to consumers outside the corporate limits of the Village of Watkins Glen shall be based on the amount of water used each month, and shall be as follows:

0-300 c.f. minimum charge per month	\$18.00
or 0-2,250 gallons minimum charge per month	\$18.00
Additional per 100 c.f. over 300 c.f.	\$ 5.93
Additional per 1,000 gallons over 2,250	\$ 7.92

In addition, the water rent charge shall be increased from \$6.50 per month to **\$7.50** per month for such users.

This Local Law shall take effect on December 1, 2015.


