**LAST DATE TO FILE:** Applications accepted until positions are filled.

**SALARY:** Salary between \$14.66 - \$20.00/hour based on experience.

**HOW TO APPLY:** Interested candidates must submit an original Civil Service “*Application for Employment and/or Examination*” to the **Schuyler County Civil Service Office**.

**VACANCY:** The Village of Watkins Glen is looking for Lifeguards for Clute Park.

**JOB DESCRIPTION:** Performs routine patrol work at the waterfront area, looking after the safety and welfare of swimmers, waterfront area and splash pad area. This is important work consisting primarily of routine patrol tasks performed under direct supervision. Employees must be constantly alert to assist swimmers when they are in difficulty and to enforce safety rules. Work requires exercise of sound judgment in emergencies. Does related work as required.

#### **TYPICAL WORK ACTIVITIES:**

Stands watch at pool or patrols bathing beach keeping bathers within bounds and going to their aid when they are in difficulty;

Applies resuscitation techniques and otherwise renders first aid;

Instructs bathers in basic water safety;

May teach some basic swimming skills and techniques;

Inspects facilities, splash pad and beach areas for safety and sanitation;

Maintains order and enforces safety rules;

May perform routine maintenance and repair of equipment and accessories.

#### **MINIMUM QUALIFICATIONS:**

A. Must be at least 15 years of age, **AND**

B. Possess current Lifeguard Certification from the American Red Cross (or equivalent) and a separate CPR certificate. Those who will work at beaches must also have the Waterfront Module. Certification must remain current throughout the operating season. Copies of all signed certification cards must be submitted with application.
